### **"5 Day Money Back Return Guarantee"**

We stand behind our puppies with a 100% 5 Day Money Back Return Guarantee & our 1 Year Health Guarantee. Within 5 days of receiving the puppy, you can bring them back to us and get your money back. You will only incur the cost of shipping. To return the puppy, we would need a signed statement by your vet stating a genetic or congenital defect with the puppy and it is his recommendation to return the puppy.

**Lifetime Guarantee:** We take great pride in having the highest quality puppies available. Our puppies are guaranteed for the first year for congenital or hereditary incurable life threatening birth defects resulting in death. In case of birth defects resulting in death, we will not issue any cash refunds, but we will replace your puppy with one of equal value. All shipping costs are at the buyers/owners expense. The time period you have to choose a replacement puppy is 6 months. Buyer/Owner is responsible for any tests or diagnostics performed.

In the event of death from a genetic defect after the first year, LoBoPuppies.com will provide a twenty percent credit toward a replacement puppy. The Buyer is responsible for ALL daily care and upkeep of the puppy; you must have kept the puppy under the care of a licensed veterinarian. The care must include all vaccinations recommended by the veterinarian and LoBoPuppies.com. This Guarantee covers only the purchase price of the puppy, and does not include shipping cost or any other cost. All shot records, registration, & veterinarian reports must be provided to LoBoPuppies.com for verification. The Agreement will come with a veterinarian exam report to give to your vet for him to fill out and fax back.

You must have your new puppy examined by a licensed veterinarian of your choice with in (3) three days of receiving the puppy. X\_\_\_\_\_BUYERS INITIALS

### **BUYERS RESPONSIBILITIES:**

Buyer/Owner agrees to have the puppy examined by a reputable veterinarian within 72 HOURS from the time of the purchase & to have the Veterinary Examination Report completed by the attending veterinarian. This report must be returned to seller immediately following the examination. Failure to return written report within 24 hours of exam invalidates this agreement. It is the responsibility of the buyer to provide immediate veterinary care to any puppy showing signs of illness or distress & failure to do so will render any guarantee null and void. Under no circumstance is a puppy to be destroyed prior to notification by the seller. If a puppy some reason dies within the guarantee period, despite medical treatment, replacement will be made ONLY if a veterinarian certifies the cause of death. Seller is not liable for any medical bills. Seller will not be held liable for any medical or behavioral problems due to transit. If death occurs an autopsy will be required for a replacement.

We do not cover cherry eye, parvo, coccidia, Kennel cough, entropion, Hypoplastic trachea, demodex, hernias, or any skin disorders due to the fact that this is very common in Bulldogs. (French or English)

You can get first pick of next available litter if you change your mind on a puppy, or if puppy you chose is not available to be sold because of unforeseen situations arise, you get 1st pick from puppy that is comparable to the price you have paid for said puppy. This agreement is Null and Void if the terms and Conditions are not fulfilled: & if the contract is not signed & returned back to Lobopuppies.com before the puppy is shipped, picked up, or released by seller. Proof that veterinarian report faxed over to seller is the responsibility of the buyer and must be provided before replacement puppy can be provided.

**This guarantee is null and void if:**

- 1. This Puppy Adoption Agreement is not signed and faxed back to us within 72 hours of purchase.**
- 2. Veterinarian Report is not faxed or mailed within 24 hours of report.**
- 3. The Buyer does not maintain preventative health care of the puppy/dog.**
- 4. The puppy/dog is chained or tied outside or left alone in a kennel.**
- 5. The puppy/dog is not kept under close veterinarian supervision. (Regular checkups)**
- 6. The puppy/dog has been bred.**

**\*Puppy/Dog Should Not be left outside if weather is 90% degrees or more. Even with Shade a puppy/Dog can get way to Hot, & have a possible heat stroke.**

This agreement is made and entered into the State of Texas and shall be enforced and interpreted under the laws of this state.

**I, the buyer of a puppy/dog from seller hereby acknowledge that I have received a copy of this document. Further, I accept the terms and conditions of the guarantee printed in this document, and I waive and relinquish any and all other rights that I might otherwise have in the event of such occurrence. Venue and jurisdiction for litigation arising out of or related to this agreement shall lie exclusively in Tarrant County, TX. Buyer acknowledges that he or she has read, understands and agrees to the terms of this document.**
